# SUPPLEMENT TO "AN EQUILIBRIUM THEORY OF LEARNING, SEARCH AND WAGES" 

(Econometrica, Vol. 78, No. 2, March 2010, 509-537)
By Francisco M. Gonzalez and Shouyong Shi

This supplementary appendix provides complete proofs of the lemmas and theorems presented in the paper.

## A. PROOFS OF THEOREM 3.1 AND TWO LEMMAS

Proof of Theorem 3.1: First, we prove existence of the equilibrium. The analysis leading to Theorem 3.1 has proven that if $V$ obeys (3.7), then $V$ and the optimal choices $G(\mu)$ exist. In Section 6, we characterize the steady state distribution of workers. Thus, for existence of an equilibrium it suffices to show that Assumption 2 is sufficient for all matches to be accepted, in which case $V$ indeed obeys (3.7).

Consider a worker with beliefs $\mu \in M$ who obtains a match in submarket $x \in X$. Accepting the match yields the present value, $J_{e}(\phi(\mu), W(x))$, and rejecting the match yields $V(\phi(\mu))$. The worker strictly prefers to accept the match if and only if $J_{e}(\phi(\mu), W(x))>V(\phi(\mu))$. Using (3.5), we can rewrite the latter condition as $W(x)>(r+\sigma) V(\phi(\mu))$. Since $W^{\prime}(x)<0$ and $\phi(\mu) \leq a_{H}$, a sufficient condition for this requirement to hold for all $x$ and $\mu$ is

$$
W\left(a_{H}^{-1}\right)>(r+\sigma) V\left(a_{H}\right)
$$

Substituting $V\left(a_{H}\right)$ from (A.1) in Lemma A. 1 below, we rewrite the condition as

$$
(y-b) / c>\left[A+a_{H} x_{H}\right] \lambda^{\prime}\left(x^{*}\right)-a_{H} \lambda\left(x_{H}\right),
$$

where $x^{*}$ is defined by $\lambda^{\prime}\left(x^{*}\right)=a_{H} \lambda\left(a_{H}^{-1}\right)$ and $x_{H}=g\left(a_{H}\right)$. Since the right-hand side of the inequality is maximized at $x_{H}=x^{*}$, Assumption 2 is sufficient for the inequality to hold and, hence, for all matches to be accepted.

Second, we prove that $g(\mu)>0$ for all $g(\mu) \in G(\mu)$ and all $\mu \in M$. Let $\mu \in M$ be arbitrary beliefs and let $g(\mu)$ be an arbitrary selection from the set of optimal choices, $G(\mu)$. Suppose that $g(\mu)=0$, contrary to the theorem. In this case, (3.6) and (3.7) yield $R(0, \mu)=V(\mu)=b /(r+\sigma)$. Consider a choice $x>0$. Because it is always feasible for the worker to choose $x^{\prime}=0$ in the future, the future value function satisfies $V\left(\mu^{\prime}\right) \geq b /(r+\sigma)$ for all posterior beliefs $\mu^{\prime}$. Thus, for all $\mu$, the choice $x$ yields at least the payoff

$$
\tilde{R}(x, \mu)=\frac{x \mu}{A}\left[\frac{W(x)}{1-\sigma}+\frac{\delta b}{r+\sigma}\right]+(1-x \mu) \frac{b}{r+\sigma} .
$$

Note that $\tilde{R}(x, \mu)$ is differentiable and strictly concave in $x$. Substituting $W(\cdot)$ from (3.10), we can verify that $\tilde{R}_{1}(0, \mu)>0$ if and only if $(y-b) / c>A \lambda^{\prime}(0)$. Since the latter condition is satisfied (see Remark 1), then $\max _{x} \tilde{R}(x, \mu)>$ $\tilde{R}(0, \mu)=b /(r+\sigma)$. This is a contradiction. Therefore, $g(\mu)>0$ for all $\mu$.

Third, we prove that $V$ is strictly increasing. Let $T V(\mu)$ denote the righthand side of (3.7). Since $T$ is a contraction mapping on the space of continuous functions on $M$ (with the sup norm), it suffices to prove that $T$ maps continuous and increasing functions on $M$ into continuous and strictly increasing functions on $M$ (see Stokey, Lucas, and Prescott (1989)). Namely, we prove that $T V\left(\mu_{a}\right)>T V\left(\mu_{b}\right)$ for any continuous and increasing function $V$ on $M$ and for arbitrary $\mu_{a}, \mu_{b} \in M$, with $\mu_{a}>\mu_{b}$. Denote $g_{i}=g\left(\mu_{i}\right) \in G\left(\mu_{i}\right)$, where $i \in\{a, b\}$. We have

$$
\begin{aligned}
& R\left(g_{a}, \mu_{a}\right)-R\left(g_{b}, \mu_{b}\right) \\
& \quad \geq R\left(g_{b}, \mu_{a}\right)-R\left(g_{b}, \mu_{b}\right) \\
& \quad \geq g_{b}\left(\mu_{a}-\mu_{b}\right)\left\{\frac{W\left(g_{b}\right)}{A(1-\sigma)}+\frac{\delta}{A} V\left(\phi\left(\mu_{b}\right)\right)-V\left(H\left(g_{b}, \mu_{b}\right)\right)\right\} \\
& \quad>g_{b}\left(\mu_{a}-\mu_{b}\right)\left[V\left(\phi\left(\mu_{b}\right)\right)-V\left(H\left(g_{b}, \mu_{b}\right)\right)\right] \\
& \quad \geq 0 .
\end{aligned}
$$

The first inequality comes from the fact that $g_{i} \in \arg \max _{x} R\left(x, \mu_{i}\right)$ and the second inequality comes from $V\left(H\left(g_{b}, \mu_{a}\right)\right) \geq V\left(H\left(g_{b}, \mu_{b}\right)\right)$. The strict inequality uses the fact that $g_{b}>0$ and that Assumption 2 implies $W(x)>$ $(r+\sigma) V(\phi(\mu))$ for all $x$ and $\mu$ (see the second paragraph of the current proof of Theorem 3.1). The last inequality comes from $\phi\left(\mu_{b}\right) \geq H\left(g_{b}, \mu_{b}\right)$. Hence, $T V\left(\mu_{a}\right)>T V\left(\mu_{b}\right)$.

Finally, (weak) convexity of $V$ follows from standard arguments (e.g., Nyarko (1994, Proposition 3.2)). Because a convex function is almost everywhere differentiable (see Royden (1988, pp. 113-114)), $V$ is almost everywhere differentiable.
Q.E.D.

The following lemmas (duplicated from the main text) are used in the proofs of other results.

LEMMA A.1: Denote $x_{i}=g\left(a_{i}\right)$, where $i \in\{H, L\}$. The following results hold: (i) The optimal choice $x_{i}$ is unique and satisfies $R_{1}\left(x_{i}, a_{i}\right) \geq 0$, with strict inequality only if $x_{i}=1 / a_{H}$. The value function satisfies
(A.1) $\quad V\left(a_{i}\right)=\frac{A b+a_{i} x_{i} W\left(x_{i}\right)}{(r+\sigma)\left[A+a_{i} x_{i}\right]}$.
(ii) Condition (4.2) is necessary and sufficient for $x_{H}<1 / a_{H}$.Also, $x_{L} \geq x_{H}$ with strict inequality if $x_{H}<1 / a_{H}$. (iii) $\delta / A<V^{\prime}\left(a_{L}^{+}\right) / V^{\prime}\left(a_{H}^{-}\right)$for all $\delta \leq \bar{\delta}$, where $\bar{\delta}$
is the smallest positive solution to $\Omega(\delta)=0$ and $\Omega$ is defined as

$$
\begin{equation*}
\Omega(\delta)=\frac{r+\sigma}{1-\sigma}\left(\frac{r+\sigma}{1-\sigma}+\delta\right)^{2}-\delta\left[\left(1+\frac{a_{L}}{a_{H}}\right)\left(\frac{r+\sigma}{1-\sigma}+\delta\right)+\frac{a_{L}}{a_{H}}\right] \tag{A.2}
\end{equation*}
$$

Proof: (i) Since the proofs are similar for the cases $i=H$ and $i=L$, we only give the proof for $i=H$. Noting that $\phi\left(a_{H}\right)=H\left(x, a_{H}\right)=a_{H}$ for all $x$, we get

$$
R\left(x, a_{H}\right)=\frac{x a_{H}}{A}\left[\frac{W(x)}{1-\sigma}+\delta V\left(a_{H}\right)\right]+\left(1-x a_{H}\right) V\left(a_{H}\right)
$$

and $(1+r) V\left(a_{H}\right)=b+(1-\sigma) \max _{x} R\left(x, a_{H}\right)$. Condition (iii) in (3.11) implies that $R\left(x, a_{H}\right)$ is strictly concave in $x$ and so the optimal choice, $x_{H}$, is unique. Since $R\left(x, a_{H}\right)$ is differentiable with respect to $x$ and since $x_{H}>0$ by Theorem 3.1, then $x_{H}$ satisfies the condition $R_{1}\left(x_{H}, a_{H}\right) \geq 0$ with strictly inequality only if $x_{H}=1 / a_{H}$. The Bellman equation $(1+r) V\left(a_{H}\right)=b+(1-\sigma) R\left(x_{H}, a_{H}\right)$ yields (A.1) for $i=H$.
(ii) From part (i), it is clear that $x_{H}<1 / a_{H}$ if and only if $R_{1}\left(a_{H}^{-1}, a_{H}\right)<0$, which can be rewritten as

$$
\begin{equation*}
W\left(a_{H}^{-1}\right)+a_{H}^{-1} W^{\prime}\left(a_{H}^{-1}\right)<(r+\sigma) V\left(a_{H}\right) \tag{A.3}
\end{equation*}
$$

Substituting $V\left(a_{H}\right)$ from (A.1) and $W(x)$ from (3.10), we find that (A.3) is equivalent to

$$
(y-b) / c<\left[A+a_{H} x_{H}\right] \lambda^{\prime}\left(a_{H}^{-1}\right)-a_{H} \lambda\left(x_{H}\right) .
$$

The right-hand side is an increasing function of $x_{H}$ and its value at $x_{H}=1 / a_{H}$ is equal to the right-hand side of (4.2). Since $x_{H} \leq 1 / a_{H}$, (4.2) is necessary for the above condition and, hence, necessary for $x_{H}<1 / a_{H}$. On the other hand, if $x_{H}=1 / a_{H}$, then $R_{1}\left(a_{H}^{-1}, a_{H}\right) \geq 0$, and $V\left(a_{H}\right)$ is given by (A.1) with $i=H$ and $x_{H}=1 / a_{H}$. Substituting this value of $V\left(a_{H}\right)$, we find that the condition $R_{1}\left(a_{H}^{-1}, a_{H}\right) \geq 0$ violates (4.2). Thus, (4.2) is also sufficient for $x_{H}<1 / a_{H}$.

The condition $R_{1}\left(x_{i}, a_{i}\right) \geq 0$ holds for both $i=H$ and $L$. Inspecting this condition and using strict monotonicity of the value function, we can deduce that $x_{L} \geq x_{H}$, where the inequality is strict if $x_{H}<1 / a_{H}$.
(iii) First, we derive an upper bound on $V^{\prime}\left(a_{H}^{-}\right)$and a lower bound on $V^{\prime}\left(a_{L}^{+}\right)$. These one-sided derivatives exist because $V$ is continuous and convex (see Royden (1988, pp. 113-114)). Let $\varepsilon>0$ be a sufficiently small number. For $V^{\prime}\left(a_{H}^{-}\right)$, we can compute

$$
\begin{aligned}
\frac{1+r}{1-\sigma}\left[V\left(a_{H}\right)-V\left(a_{H}-\varepsilon\right)\right] & =R\left(x_{H}, a_{H}\right)-R\left(g\left(a_{H}-\varepsilon\right), a_{H}-\varepsilon\right) \\
& \leq R\left(x_{H}, a_{H}\right)-R\left(x_{H}, a_{H}-\varepsilon\right)
\end{aligned}
$$

Dividing by $\varepsilon$ and taking the limit $\varepsilon \downarrow 0$, we obtain $(1+r) V^{\prime}\left(a_{H}^{-}\right) \leq(1-$ $\sigma) R_{2}\left(x_{H}, a_{H}^{-}\right)$. Using the facts $\phi\left(a_{H}\right)=a_{H}=H\left(x_{H}, a_{H}\right), \phi^{\prime}\left(a_{H}\right)=a_{L} / a_{H}$, and $H_{2}\left(x_{H}, a_{H}\right)=\left(1-x_{H} a_{L}\right) /\left(1-x_{H} a_{H}\right)$, we can compute

$$
\begin{aligned}
R_{2}\left(x_{H}, a_{H}^{-}\right)= & \frac{x_{H}}{(1-\sigma) A}\left[W\left(x_{H}\right)-(r+\sigma) V\left(a_{H}^{-}\right)\right] \\
& +\left[1-\frac{(r+\sigma) x_{H} a_{L}}{(1-\sigma) A}\right] V^{\prime}\left(a_{H}^{-}\right)
\end{aligned}
$$

Substituting $V\left(a_{H}\right)$ from (A.1) and substituting the result into the inequality, $(1+r) V^{\prime}\left(a_{H}^{-}\right) \leq(1-\sigma) R_{2}\left(x_{H}, a_{H}^{-}\right)$, we get

$$
V^{\prime}\left(a_{H}^{-}\right) \leq \frac{A x_{H}\left[W\left(x_{H}\right)-b\right]}{(r+\sigma)\left[A+x_{H} a_{L}\right]\left[A+a_{H} x_{H}\right]} .
$$

Similarly, we can derive the lower bound

$$
V^{\prime}\left(a_{L}^{+}\right) \geq \frac{A x_{L}\left[W\left(x_{L}\right)-b\right]}{(r+\sigma)\left[A+x_{L} a_{H}\right]\left[A+a_{L} x_{L}\right]}
$$

Next, we prove that $\delta / A<V^{\prime}\left(a_{L}^{+}\right) / V^{\prime}\left(a_{H}^{-}\right)$for all $\delta \leq \bar{\delta}$. Substituting the above bounds on $V^{\prime}\left(a_{H}^{-}\right)$and $V^{\prime}\left(a_{L}^{+}\right)$, we find that

$$
\frac{V^{\prime}\left(a_{L}^{+}\right)}{V^{\prime}\left(a_{H}^{-}\right)} \geq \frac{x_{L}\left[W\left(x_{L}\right)-b\right]\left[A+x_{H} a_{L}\right]\left[A+a_{H} x_{H}\right]}{x_{H}\left[W\left(x_{H}\right)-b\right]\left[A+x_{L} a_{H}\right]\left[A+a_{L} x_{L}\right]} .
$$

Recall that $x_{i}$ satisfies $R_{1}\left(x_{i}, a_{i}\right) \geq 0$ for $i \in\{H, L\}$ and the value function satisfies $V\left(a_{i}\right)>b /(r+\sigma)$. Using these results, we can verify that $x[W(x)-b]$ is strictly increasing in $x$ for $x \in\left[x_{H}, x_{L}\right]$. Because $x_{L} \geq x_{H}$ (see the proof of (ii) above), $x_{L}\left[W\left(x_{L}\right)-b\right] \geq x_{H}\left[W\left(x_{H}\right)-b\right]$. Substituting this result and the facts that $x_{H}>0$ and $x_{L} \leq 1 / a_{H}$, we conclude that

$$
\frac{V^{\prime}\left(a_{L}^{+}\right)}{V^{\prime}\left(a_{H}^{-}\right)}>\frac{A^{2}}{[A+1]\left[A+\frac{a_{L}}{a_{H}}\right]}
$$

Substituting this bound, we find that a sufficient condition for $\delta / A<V^{\prime}\left(a_{L}^{+}\right) /$ $V^{\prime}\left(a_{H}^{-}\right)$is $\Omega(\delta) \geq 0$, where $\Omega(\delta)$ is defined in (A.2). The function $\Omega(\delta)$ is quadratic and involves only the parameters of the model. Because $\Omega(0)>0$, there exists $\bar{\delta}>0$ such that $\Omega(\delta) \geq 0$ for all $\delta \in[0, \bar{\delta}]$. Thus, $\delta / A<$ $V^{\prime}\left(a_{L}^{+}\right) / V^{\prime}\left(a_{H}^{-}\right)$for all $\delta \in[0, \bar{\delta}]$.
Q.E.D.

Lemma A.2: For any given $z$, the functions $\mu V(\phi(\mu))$ and $(1+z \mu) V \times$ $(H(-z, \mu))$ are convex in $\mu$ if $V(\cdot)$ is convex, and strictly convex in $\mu$ if $V(\cdot)$ is strictly convex.

Proof: Assume that $V$ is convex. Take arbitrary $\mu_{a}$ and $\mu_{b}$ in $M$, with $\mu_{a}>\mu_{b}$. Let $\gamma$ be an arbitrary number in $(0,1)$ and define $\mu_{\gamma}=\gamma \mu_{a}+(1-$ $\gamma) \mu_{b}$. We first prove that $\mu_{\gamma} V\left(\phi\left(\mu_{\gamma}\right)\right) \leq \gamma \mu_{a} V\left(\phi\left(\mu_{a}\right)\right)+(1-\gamma) \mu_{b} V\left(\phi\left(\mu_{b}\right)\right)$, which establishes convexity of $\mu V(\phi(\mu))$. Shorten the notation $\phi\left(\mu_{i}\right)$ to $\phi_{i}$, where $i \in\{a, b, \gamma\}$. Denote $\kappa=\left(\phi_{\gamma}-\phi_{b}\right) /\left(\phi_{a}-\phi_{b}\right)$. Clearly, $\kappa \in[0,1]$ and $\phi_{\gamma}=\kappa \phi_{a}+(1-\kappa) \phi_{b}$. Moreover, since $\mu \phi(\mu)$ is a linear function of $\mu$, we can verify that $\kappa \mu_{\gamma}=\gamma \mu_{a}$ and $(1-\kappa) \mu_{\gamma}=(1-\gamma) \mu_{b}$. Thus,

$$
\begin{aligned}
\mu_{\gamma} V\left(\phi_{\gamma}\right) & =\mu_{\gamma} V\left(\kappa \phi_{a}+(1-\kappa) \phi_{b}\right) \\
& \leq \mu_{\gamma}\left[\kappa V\left(\phi_{a}\right)+(1-\kappa) V\left(\phi_{b}\right)\right] \\
& =\gamma \mu_{a} V\left(\phi_{a}\right)+(1-\gamma) \mu_{b} V\left(\phi_{b}\right) .
\end{aligned}
$$

The inequality comes from convexity of $V$ and the fact that $\mu_{\gamma}>0$. The last equality comes from the facts that $\kappa \mu_{\gamma}=\gamma \mu_{a}$ and $(1-\kappa) \mu_{\gamma}=(1-\gamma) \mu_{b}$. If $V$ is strictly convex, then the above inequality is strict, in which case $\mu V(\phi(\mu))$ is strictly convex.

Note that the function $(1+z \mu) H(-z, \mu)$ is also linear in $\mu$ for any given $z$. A similar proof as the above establishes that this function is convex if $V$ is convex and is strictly convex if $V$ is strictly convex.
Q.E.D.

## B. PROOF OF THEOREM 4.1

First, we prove that $\hat{R}(z, \mu)$ is strictly supermodular. Take arbitrary $z_{a}$, $z_{b} \in-X$ and arbitrary $\mu_{a}, \mu_{b} \in M$, with $z_{a}>z_{b}$ and $\mu_{a}>\mu_{b}$. Denote

$$
D=\left[\hat{R}\left(z_{a}, \mu_{a}\right)-\hat{R}\left(z_{a}, \mu_{b}\right)\right]-\left[\hat{R}\left(z_{b}, \mu_{a}\right)-\hat{R}\left(z_{b}, \mu_{b}\right)\right] .
$$

We need to show $D>0$. Temporarily denote $\phi_{j}=\phi\left(\mu_{j}\right), H_{i j}=H\left(-z_{i}, \mu_{j}\right)$, and $V_{i j}=V\left(H_{i j}\right)$, where $i, j \in\{a, b\}$. Computing $D$, we have

$$
D=D_{1}-\frac{\delta}{A}\left[V\left(\phi_{a}\right)-V\left(\phi_{b}\right)\right]\left(z_{a}-z_{b}\right)
$$

where

$$
D_{1}=\left(z_{a}+\mu_{a}^{-1}\right) V_{a a}-\left(z_{b}+\mu_{a}^{-1}\right) V_{b a}-\left(z_{a}+\mu_{b}^{-1}\right) V_{a b}+\left(z_{b}+\mu_{b}^{-1}\right) V_{b b}
$$

Denote $\tilde{H}=\min \left\{H_{b a}, H_{a b}\right\}$. Because $H(-z, \mu)$ is a strictly increasing function of $z$ and $\mu$ for all $\mu \in\left(a_{L}, a_{H}\right)$, then $H_{a a}>\tilde{H} \geq H_{b b}$. Because $V$ is convex, we have

$$
\min \left\{\frac{V_{a a}-V_{b a}}{H_{a a}-H_{b a}}, \frac{V_{a a}-V_{a b}}{H_{a a}-H_{a b}}\right\} \geq \frac{V_{a a}-V(\tilde{H})}{H_{a a}-\tilde{H}} \geq \frac{V_{a a}-V_{b b}}{H_{a a}-H_{b b}}
$$

Substituting $V_{b a}, V_{a b}$, and $V_{b b}$ from these inequalities, and substituting $H$, we have

$$
\begin{aligned}
D_{1} \geq & \frac{V_{a a}-V(\tilde{H})}{H_{a a}-\tilde{H}}\left\{\frac{1}{\mu_{a}}\left[\left(1+z_{a} \mu_{a}\right) H_{a a}-\left(1+z_{b} \mu_{a}\right) H_{b a}\right]\right. \\
& \left.-\frac{1}{\mu_{b}}\left[\left(1+z_{a} \mu_{b}\right) H_{a b}-\left(1+z_{b} \mu_{b}\right) H_{b b}\right]\right\} \\
= & \frac{V_{a a}-V(\tilde{H})}{H_{a a}-\tilde{H}}\left(z_{a}-z_{b}\right)\left(\phi_{a}-\phi_{b}\right) .
\end{aligned}
$$

Thus, $D>0$ if

$$
\frac{\delta}{A}<\left[\frac{V_{a a}-V(\tilde{H})}{H_{a a}-\tilde{H}}\right] /\left[\frac{V\left(\phi_{a}\right)-V\left(\phi_{b}\right)}{\phi_{a}-\phi_{b}}\right]
$$

Because $V$ is convex, then

$$
\frac{V_{a a}-V(\tilde{H})}{H_{a a}-\tilde{H}} \geq V^{\prime}\left(a_{L}^{+}\right) ; \quad \frac{V\left(\phi_{a}\right)-V\left(\phi_{b}\right)}{\phi_{a}-\phi_{b}} \leq V^{\prime}\left(a_{H}^{-}\right),
$$

where $V^{\prime}\left(\mu^{+}\right)$is the right derivative and $V^{\prime}\left(\mu^{-}\right)$is the left derivative of $V$ at $\mu$. Hence, a sufficient condition for $D>0$ is $\delta / A<V^{\prime}\left(a_{L}^{+}\right) / V^{\prime}\left(a_{H}^{-}\right)$, which is implied by Assumption 3 (see Lemma A.1).

Thus, the function $\hat{R}(z, \mu)$ is strictly supermodular. Because $-X$ is a lattice, the monotone selection theorem in Topkis (1998, Theorem 2.8.4, p. 79) implies that every selection from $Z(\mu)$ is increasing. As a result, every selection $g(\mu)$ from $G(\mu)$ is decreasing and $w(\mu)=W(g(\mu))$ is increasing.

Finally, we establish that statements (i)-(v) in Theorem 4.1 are equivalent.
(i) $\Longleftrightarrow$ (ii) Optimal learning has the following standard property (see Nyarko (1994, Proposition 4.1)): The value function is strictly convex in beliefs if and only if there do not exist $\mu_{a}$ and $\mu_{b}$ in $M$, with $\mu_{a}>\mu_{b}$, and a choice $z_{0}$ such that $z_{0} \in Z(\mu)$ for all $\mu \in\left[\mu_{b}, \mu_{a}\right]$. Since $z(\mu)$ is an increasing function, as proven above, the standard property implies that $V$ is strictly convex if and only if every selection $z(\mu)$ is strictly increasing for all $\mu$.
(ii) $\Longrightarrow$ (iii) Suppose $\left\{-a_{H}^{-1}\right\} \in Z\left(\mu_{a}\right)$ for some $\mu_{a}>a_{L}$ so that (iii) is violated. Because every selection $z(\mu)$ is increasing, $Z(\mu)$ contains only the singleton $\left\{-a_{H}^{-1}\right\}$ for all $\mu<\mu_{a}$. In this case, (ii) does not hold for $\mu \leq \mu_{a}$. Note that since $z(\mu)<0$ by Theorem 3.1, the result $\left\{-a_{H}^{-1}\right\} \notin Z(\mu)$ implies that $Z(\mu)$ is interior.
(iii) $\Longrightarrow$ (iv) This follows from $a_{H}>a_{L}$.
(iv) $\Longleftrightarrow$ (v) See part (ii) of Lemma A.1.
(iv) $\Longrightarrow$ (i) We prove that a violation of (i) implies that $\left\{-a_{H}^{-1}\right\} \in Z\left(a_{H}\right)$, which violates (iv). Suppose that $V$ is not strictly convex. Proposition 4.1 in

Nyarko (1994) implies that there exist $\mu_{a}$ and $\mu_{b}$ in $M$, with $\mu_{a}>\mu_{b}$, and a choice $z_{0}$ such that $z_{0} \in Z(\mu)$ and $V(\mu)$ is linear for all $\mu \in\left[\mu_{b}, \mu_{a}\right]$. Since $\mu_{a}>\mu_{b}$, let $\mu_{b}>a_{L}$ and $\mu_{a}<a_{H}$ without loss of generality. (If $\mu_{a}$ or $\mu_{b}$ is at the boundary, we can find $\mu_{a}^{\prime}$ and $\mu_{b}^{\prime}$, with $\mu_{a}>\mu_{a}^{\prime}>\mu_{b}^{\prime}>\mu_{b}$.) We deduce that $V(\mu)$ is linear for all $\mu \in\left[\phi\left(\mu_{b}\right), \phi\left(\mu_{a}\right)\right]$ : If $V(\mu)$ were strictly convex in any subinterval of $\left[\phi\left(\mu_{b}\right), \phi\left(\mu_{a}\right)\right]$, Lemma A. 2 above would imply that $R\left(-z_{0}, \mu\right)$ is strictly convex $\mu$ in some subinterval of $\left[\mu_{b}, \mu_{a}\right.$ ]. Similarly, $V(\mu)$ is linear for all $\mu \in\left[H_{b}, H_{a}\right]$, where $H_{i}$ denotes $H\left(-z_{0}, \mu_{i}\right)$ for $i \in\{a, b\}$. Denote the slope of $V$ as $V^{\prime}\left(\phi_{b}\right)$ for $\mu \in\left[\phi\left(\mu_{b}\right), \phi\left(\mu_{a}\right)\right]$ and $V^{\prime}\left(H_{b}\right)$ for $\mu \in\left[H_{b}, H_{b}\right]$. For all $\mu \in\left[\mu_{b}, \mu_{a}\right]$, we have

$$
\begin{aligned}
\hat{R}(z, \mu)= & -\frac{z W(-z)}{(1-\sigma) A}-\frac{\delta z}{A}\left\{V\left(\phi\left(\mu_{b}\right)\right)+V^{\prime}\left(\phi_{b}\right)\left[\phi(\mu)-\phi\left(\mu_{b}\right)\right]\right\} \\
& +\frac{1}{\mu}(1+z \mu)\left\{V\left(H_{b}\right)+V^{\prime}\left(H_{b}\right)\left[H(-z, \mu)-H_{b}\right]\right\}
\end{aligned}
$$

Because $(1+z \mu) H(-z, \mu)$ is linear in $z$, the last two terms in the above expression are linear in $z$. In this case, part (iii) in (3.11) implies that $\hat{R}(z, \mu)$ is strictly concave in $z$ and twice continuously differentiable in $z$ and $\mu$ for all $\mu \in\left[\mu_{b}, \mu_{a}\right]$. Thus, the optimal choice $z(\mu)$ is unique. By the supposition, this optimal choice is $z(\mu)=z_{0}$ for all $\mu \in\left[\mu_{b}, \mu_{a}\right]$. Using these results and the fact that $z_{0}<0$ (see Theorem 3.1), we conclude that $z_{0}$ satisfies the complementary slackness condition $\hat{R}_{1}\left(z_{0}, \mu\right) \leq 0$ and $z_{0} \geq-1 / a_{H}$. Moreover, in this case, strict supermodularity of $\hat{R}$ implies $\hat{R}_{12}(z, \mu)>0$ and strictly concavity of $\hat{R}$ in $z$ implies $\hat{R}_{11}(z, \mu)<0$ for all $\mu \in\left[\mu_{b}, \mu_{a}\right]$. If $z_{0}>-1 / a_{H}$, then $\hat{R}_{1}\left(z_{0}, \mu\right)=0$, which implies $d z_{0} / d \mu=-\hat{R}_{12} / \hat{R}_{11}>0$. This contradicts the supposition that $z_{0}$ is constant for all $\mu \in\left[\mu_{b}, \mu_{a}\right]$. Thus, $z_{0}=-1 / a_{H}$.

Repeat the above argument for all $\mu \in\left[\phi^{i}\left(\mu_{b}\right), \phi^{i}\left(\mu_{a}\right)\right]$, where $\phi^{i}(\mu)=$ $\phi\left(\phi^{i-1}(\mu)\right)$ and $i=1,2, \ldots$. For such $\mu, V$ is linear and $Z(\mu)$ is the singleton $\left\{-a_{H}^{-1}\right\}$.

Take an arbitrary $\mu_{c} \in\left(\mu_{b}, \mu_{a}\right)$. Since $Z\left(\phi^{i}\left(\mu_{c}\right)\right)=\left\{-a_{H}^{-1}\right\}$ for all positive integers $i$, then $\lim _{i \rightarrow \infty} Z\left(\phi^{i}\left(\mu_{c}\right)\right)=\left\{-a_{H}^{-1}\right\}$. From the definition of $\phi(\mu)$, it is clear that $\phi\left(a_{H}\right)=a_{H}, \phi\left(a_{L}\right)=a_{L}$, and $\phi(\mu)>\mu$ for all $\mu \in$ $\left(a_{L}, a_{H}\right)$. Thus, $\lim _{i \rightarrow \infty} \phi^{i}(\mu)=a_{H}$ for every $\mu \in\left(a_{L}, a_{H}\right)$ and, particularly, for $\mu=\mu_{c}$. Because $Z$ is upper hemicontinuous, we conclude that $\left\{-a_{H}^{-1}\right\} \in$ $Z\left(a_{H}\right)$.
Q.E.D.

## B.1. The Relationship Between Single Crossing and Supermodularity

The original objective function of a worker's maximization problem is

$$
R(-z, \mu)=-\frac{z \mu}{A}\left[\frac{W(-z)}{1-\sigma}+\delta V(\phi(\mu))\right]+(z \mu+1) V(H(-z, \mu))
$$

The transformed function is $\hat{R}(z, \mu)=\frac{1}{\mu} R(-z, \mu)$. Consider arbitrary $z_{a}$, $z_{b} \in-X$ and arbitrary $\mu_{a}, \mu_{b} \in M$, with $z_{a}>z_{b}$ and $\mu_{a}>\mu_{b}$. The original function $R$ has strict single crossing in $(z, \mu)$ if

$$
R\left(-z_{a}, \mu_{b}\right) \geq R\left(-z_{b}, \mu_{b}\right) \quad \Longrightarrow \quad R\left(-z_{a}, \mu_{a}\right)>R\left(-z_{b}, \mu_{a}\right)
$$

The transformed function $\hat{R}$ is strictly supermodular in $(z, \mu)$ if

$$
D \equiv\left[\hat{R}\left(z_{a}, \mu_{a}\right)-\hat{R}\left(z_{b}, \mu_{a}\right)\right]-\left[\hat{R}\left(z_{a}, \mu_{b}\right)-\hat{R}\left(z_{b}, \mu_{b}\right)\right]>0 .
$$

Claim 1: Strict supermodularity of $\hat{R}(z, \mu)$ is sufficient but not necessary for strict single crossing of $R(-z, \mu)$.

Proof: Consider arbitrary $z_{a}, z_{b}, \mu_{a}$, and $\mu_{b}$ in the above definitions. Substituting $\hat{R}=R / \mu$ into the definition of $D$ and rearranging terms, we have

$$
R\left(-z_{a}, \mu_{a}\right)-R\left(-z_{b}, \mu_{a}\right)=\mu_{a} D+\frac{\mu_{a}}{\mu_{b}}\left[R\left(-z_{a}, \mu_{b}\right)-R\left(-z_{b}, \mu_{b}\right)\right]
$$

Suppose that $\hat{R}(z, \mu)$ is strictly supermodular in $(z, \mu)$, that is, $D>0$. If $R\left(-z_{a}, \mu_{b}\right) \geq R\left(-z_{b}, \mu_{b}\right)$, then the above equation clearly implies $R\left(-z_{a}\right.$, $\left.\mu_{a}\right)>R\left(-z_{b}, \mu_{a}\right)$, which establishes strict single crossing of $R$. The converse is not true. If $R$ has strict single crossing, then $\frac{\mu_{a}}{\mu_{b}}\left[R\left(-z_{a}, \mu_{b}\right)-R\left(-z_{b}, \mu_{b}\right)\right] \geq 0$ implies $\left[R\left(-z_{a}, \mu_{a}\right)-R\left(-z_{a}, \mu_{a}\right)\right]>0$. However, the first difference can be greater than the second difference, in which case $D<0$.
Q.E.D.

In practice, verifying strict supermodularity of $\hat{R}$ is the operational way to verify strict single crossing of $R$, although the former is not necessary for the latter. To see why, suppose that $R\left(-z_{a}, \mu_{b}\right) \geq R\left(-z_{b}, \mu_{b}\right)$. To verify that $R$ has strict single crossing, we need to verify that $R\left(-z_{a}, \mu_{a}\right)-R\left(-z_{b}, \mu_{a}\right)>0$. The latter difference involves the term $\left[z_{a} W\left(-z_{a}\right)-z_{b} W\left(-z_{b}\right)\right]$. For arbitrary $\left(z_{a}, z_{b}\right)$, this term is unrelated to $\left(\mu_{a}, \mu_{b}\right)$ and it can be either positive or negative (because the function $z W(-z)$ is not monotone). The operational way to verify strict single crossing of $R$ is to use the hypothesis in strict single crossing to substitute the above term. That is, rewrite the hypothesis $R\left(-z_{a}, \mu_{b}\right) \geq R\left(-z_{b}, \mu_{b}\right)$ as

$$
\begin{aligned}
& \frac{z_{a} W\left(-z_{a}\right)-z_{b} W\left(-z_{b}\right)}{A(1-\sigma)} \\
& \quad \leq \frac{\delta V\left(\phi\left(\mu_{b}\right)\right)}{A}\left[z_{a}-z_{b}\right] \\
& \quad+\left[\left(z_{a}+\frac{1}{\mu_{b}}\right) V\left(H\left(-z_{a}, \mu_{b}\right)\right)-\left(z_{b}+\frac{1}{\mu_{b}}\right) V\left(H\left(-z_{b}, \mu_{b}\right)\right)\right] .
\end{aligned}
$$

Using this inequality to substitute $\left[z_{a} W\left(-z_{a}\right)-z_{b} W\left(-z_{b}\right)\right]$, we obtain

$$
R\left(-z_{a}, \mu_{a}\right)-R\left(-z_{b}, \mu_{a}\right) \geq \mu_{a} D
$$

Working on the above inequality to verify $R\left(-z_{a}, \mu_{a}\right)>R\left(-z_{b}, \mu_{a}\right)$ amounts to proving the sufficient condition, $D>0$, which is strict supermodularity of $\hat{R}$.

## C. PROOF OF THEOREM 5.1

Fix $\mu \in\left(a_{L}, a_{H}\right)$ and use the notation $h(\mu)=H(-z(\mu), \mu)$.
(i) Because $H(-z, \mu)$ is increasing in $z, H\left(-z^{+}(\mu), \mu\right)=h^{+}(\mu)$ and $H\left(-z^{-}(\mu), \mu\right)=h^{-}(\mu)$. Note that the convex function $V$ has left and right derivatives. Because $W(-z)$ is continuous, $V$ is continuous and convex, and $H$ is continuously differentiable, then

$$
\begin{aligned}
\hat{R}_{1}\left(z^{+}(\mu), \mu\right)= & \frac{z(\mu) W^{\prime}(-z(\mu))-W(-z(\mu))}{A(1-\sigma)}-\frac{\delta}{A} V(\phi(\mu)) \\
& +V(h(\mu))-\left(\mu^{-1}+z(\mu)\right) V^{\prime}\left(h^{+}(\mu)\right) H_{1}(-z(\mu), \mu)
\end{aligned}
$$

$\hat{R}_{1}\left(z^{-}(\mu), \mu\right)$ is given similarly with $h^{-}(\mu)$ replacing $h^{+}(\mu)$. Recall that $H_{1}$ denotes the derivative of $H(-z, \mu)$ with respect to $-z$, rather than to $z$. Since $H_{1}<0$ and $V$ is convex, we can deduce that $\hat{R}_{1}\left(z^{+}(\mu), \mu\right) \geq \hat{R}_{1}\left(z^{-}(\mu), \mu\right)$. However, because $z(\mu)$ is optimal, $\hat{R}_{1}\left(z^{+}(\mu), \mu\right) \leq 0 \leq \hat{R}_{1}\left(z^{-}(\mu), \mu\right)$. It must be true that $\hat{R}_{1}\left(z^{-}(\mu), \mu\right)=\hat{R}_{1}\left(z^{+}(\mu), \mu\right)=0$, which requires that $V^{\prime}\left(h^{-}(\mu)\right)=V^{\prime}\left(h^{+}(\mu)\right)=V^{\prime}(h(\mu))$.
(ii) Let $\left\{\mu_{i}\right\}$ be a sequence with $\mu_{i} \rightarrow \mu$ and $\mu_{i} \geq \mu_{i+1} \geq \mu$ for all $i$. Because $\bar{z}(\mu)$ is an increasing function, $\left\{\bar{z}\left(\mu_{i}\right)\right\}$ is a decreasing sequence and $\bar{z}\left(\mu_{i}\right) \geq \bar{z}(\mu)$ for all $i$. Thus, $\bar{z}\left(\mu_{i}\right) \downarrow z_{c}$ for some $z_{c} \geq \bar{z}(\mu)$. On the other hand, the theorem of the maximum implies that the correspondence $Z(\mu)$ is upper hemicontinuous (see Stokey, Lucas, and Prescott (1989, p. 62)). Because $\mu_{i} \rightarrow \mu$, and $\bar{z}\left(\mu_{i}\right) \in Z\left(\mu_{i}\right)$ for each $i$, upper hemicontinuity of $Z$ implies that there is a subsequence of $\left\{\bar{z}\left(\mu_{i}\right)\right\}$ that converges to an element in $Z(\mu)$. This element must be $z_{c}$, because all convergent subsequences of a convergent sequence must have the same limit. Thus, $z_{c} \in Z(\mu)$ and so $z_{c} \leq \max Z(\mu)=\bar{z}(\mu)$. Therefore, $\bar{z}\left(\mu_{i}\right) \downarrow z_{c}=\bar{z}(\mu)$, which shows that $\bar{z}(\mu)$ is right-continuous. Similarly, by examining the sequence $\left\{\mu_{i}\right\}$ with $\mu_{i} \rightarrow \mu$ and $\mu \geq \mu_{i+1} \geq \mu_{i}$ for all $i$, we can show that $\underline{z}$ is left-continuous.
(iii) Let $\mu_{a}$ be another arbitrary value in the interior of ( $a_{L}, a_{H}$ ). Because $\bar{z}(\mu)$ maximizes $R(-z, \mu)$ for each given $\mu$, then

$$
\begin{aligned}
(1+r) V\left(\mu_{a}\right) & =b+(1-\sigma) R\left(-\bar{z}\left(\mu_{a}\right), \mu_{a}\right) \\
& \geq b+(1-\sigma) R\left(-\bar{z}(\mu), \mu_{a}\right) \\
(1+r) V(\mu) & =b+(1-\sigma) R(-\bar{z}(\mu), \mu) \geq b+(1-\sigma) R\left(-\bar{z}\left(\mu_{a}\right), \mu\right)
\end{aligned}
$$

For $\mu_{a}>\mu$, we have

$$
\begin{aligned}
\frac{R\left(-\bar{z}(\mu), \mu_{a}\right)-R(-\bar{z}(\mu), \mu)}{(1+r)\left(\mu_{a}-\mu\right)} & \leq \frac{V\left(\mu_{a}\right)-V(\mu)}{(1-\sigma)\left(\mu_{a}-\mu\right)} \\
& \leq \frac{R\left(-\bar{z}\left(\mu_{a}\right), \mu_{a}\right)-R\left(-\bar{z}\left(\mu_{a}\right), \mu\right)}{(1+r)\left(\mu_{a}-\mu\right)}
\end{aligned}
$$

Take the limit $\mu_{a} \downarrow \mu$. Under (4.2), $V^{\prime}\left(H\left(-\bar{z}\left(\mu_{a}\right), \mu_{a}\right)\right)$ exists for each $\mu_{a}$ (see part (i)). Because $\bar{z}\left(\mu_{a}\right)$ is right-continuous, $\lim _{\mu_{a \downarrow \mu}} \bar{z}\left(\mu_{a}\right)=\bar{z}(\mu)$. Thus, all three ratios above converge to the same limit, $\frac{1}{1-\sigma} V^{\prime}\left(\mu^{+}\right)=\frac{1}{1+r} R_{2}\left(-\bar{z}(\mu), \mu^{+}\right)$, where

$$
\begin{aligned}
& R_{2}\left(-\bar{z}(\mu), \mu^{+}\right) \\
&= \bar{z}(\mu)\left[-\frac{W(-\bar{z}(\mu))}{(1-\sigma) A}-\frac{\delta}{A} V(\phi(\mu))+V(H(-\bar{z}(\mu), \mu))\right] \\
& \quad-\frac{\mu \bar{z}(\mu) \delta}{A} V^{\prime}\left(\phi^{+}(\mu)\right) \phi^{\prime}(\mu) \\
&+[\mu \bar{z}(\mu)+1] V^{\prime}(H(-\bar{z}(\mu), \mu)) H_{2}(-\bar{z}(\mu), \mu) .
\end{aligned}
$$

Now conduct the above exercise with $\underline{z}$ replacing $\bar{z}$. For $\mu_{a}<\mu$, we have

$$
\begin{aligned}
\frac{R\left(-\underline{z}\left(\mu_{a}\right), \mu_{a}\right)-R\left(-\underline{z}\left(\mu_{a}\right), \mu\right)}{\mu_{a}-\mu} & \leq \frac{(1+r)\left[V\left(\mu_{a}\right)-V(\mu)\right]}{(1-\sigma)\left(\mu_{a}-\mu\right)} \\
& \leq \frac{R\left(-\underline{z}(\mu), \mu_{a}\right)-R(-\underline{z}(\mu), \mu)}{\mu_{a}-\mu}
\end{aligned}
$$

Taking the limit $\mu_{a} \uparrow \mu$ and using left-continuity of $\underline{z}\left(\mu_{a}\right)$, we have $(1+$ $r) V^{\prime}\left(\mu^{-}\right)=(1-\sigma) R_{2}\left(-\underline{z}(\mu), \mu^{-}\right)$.
(iv) Convexity of $V$ implies that $V^{\prime}\left(\mu^{+}\right) \geq V^{\prime}\left(\mu^{-}\right)$. To find the conditions for $V$ to be differentiable at $\mu$, use the definition $R(-z, \mu)=\mu \hat{R}(z, \mu)$ to compute

$$
R_{2}(-z(\mu), \mu)=\hat{R}(z(\mu), \mu)+\mu \hat{R}_{2}(z(\mu), \mu)
$$

Note the following features. First, because $\hat{R}(z, \mu)$ is strictly supermodular, $\hat{R}_{2}(\bar{z}(\mu), \mu) \geq \hat{R}_{2}(\underline{z}(\mu), \mu)$, where the inequality is strict if and only if $\bar{z}(\mu)>\underline{z}(\mu)$. Second, $\mu^{+}$appears in the expression for $R_{2}\left(-z(\mu), \mu^{+}\right)$ only through the term $V^{\prime}\left(\phi^{+}(\mu)\right)$, and $\mu^{-}$appears in the expression for $R_{2}\left(-z(\mu), \mu^{-}\right)$only through the term $V^{\prime}\left(\phi^{-}(\mu)\right)$. Since $V$ is strictly convex (and $\underline{z}, \bar{z}<0$ ), we have $R_{2}\left(-z(\mu), \mu^{+}\right) \geq R_{2}\left(-z(\mu), \mu^{-}\right.$) for all $z(\mu) \in Z(\mu)$, where the inequality is strict if and only if $V^{\prime}\left(\phi^{+}(\mu)\right)>V^{\prime}\left(\phi^{-}(\mu)\right)$. Third,
$\hat{R}(\bar{z}(\mu), \mu)=\hat{R}(\underline{z}(\mu), \mu)$, since both $\bar{z}(\mu)$ and $\underline{z}(\mu)$ maximize $\hat{R}(z, \mu)$. These features imply

$$
\begin{aligned}
R_{2}\left(-\bar{z}(\mu), \mu^{+}\right) & \geq R_{2}\left(-\bar{z}(\mu), \mu^{-}\right) \\
& \geq \hat{R}\left(\underline{z}(\mu), \mu^{-}\right)+\mu \hat{R}_{2}\left(\underline{z}(\mu), \mu^{-}\right)=R_{2}\left(-\underline{z}(\mu), \mu^{-}\right)
\end{aligned}
$$

The first inequality comes from strict convexity of $V$, and it is strict if and only if $V^{\prime}\left(\phi^{+}(\mu)\right)>V^{\prime}\left(\phi^{-}(\mu)\right)$. The second inequality comes from strict supermodularity of $\hat{R}(z, \mu)$, and it is strict if and only if $\bar{z}(\mu)>\underline{z}(\mu)$. Therefore, $V^{\prime}\left(\mu^{+}\right)=V^{\prime}\left(\mu^{-}\right)$if and only if $V^{\prime}(\phi(\mu))$ exists and $\bar{z}(\mu)=\underline{z}(\mu)$.
(v) Assume that $V^{\prime}\left(\mu_{a}\right)$ exists for a particular (interior) $\mu_{a}$, such as $\mu_{a}=h(\mu)$ for any arbitrary interior $\mu$. By part (iv), $z\left(\mu_{a}\right)$ is unique and $V^{\prime}\left(\phi\left(\mu_{a}\right)\right)$ exists. Recall that $V^{\prime}\left(h\left(\mu_{a}\right)\right)$ always exists, by part (i). Since $V$ is now differentiable at all posterior beliefs reached from $\mu_{a}$ under the optimal choice, we can take each of these subsequent nodes and repeat the argument. This shows that the optimal choice is unique and the value function is differentiable at all nodes on the tree generated from $\mu_{a}$ in the equilibrium.
Q.E.D.
