This Online Appendix provides, in Section A, the proofs of the main results of Han and McCloskey (Forthcoming) and, in Section B, a proof of the claim that the quantity $\left\|\tilde{\eta}\left(\hat{\mu}_{n}\right)\right\|$ diverges in the context of the threshold crossing model made in Section 4 of Han and McCloskey (Forthcoming) as well as a set of primitive conditions, and corresponding verification of the high level assumptions made in Han and McCloskey (Forthcoming) for the threshold crossing model.

## Online Appendix A: Proofs of main results

Proof of Theorem 3.1. When $\beta=0$,

for all $\theta=(0, \mu) \in \Theta \equiv\left\{(\beta, \mu) \in \mathbb{R}^{d_{\theta}}:(\beta, h(\mu)) \in \boldsymbol{\Theta}\right\}$ since $\partial h(\mu) / \partial \pi^{\prime}$ is in the null space of $\partial \overline{\boldsymbol{g}}_{n}(\beta, \boldsymbol{\mu}) / \partial \boldsymbol{\mu}^{\prime}$ by Assumption Jac.

Proof of Theorem 3.2. First, note that

$$
\frac{\partial g^{(1)}\left(0, \mu^{(1)}\right)}{\partial \pi_{1}^{(1)}}=\frac{\partial \boldsymbol{g}^{*}\left(0, h^{(1)}\left(\mu^{(1)}\right)\right)}{\partial \pi_{1}^{(1)}}=\left.\frac{\partial \boldsymbol{g}^{*}(0, \boldsymbol{\mu})}{\partial \boldsymbol{\mu}^{\prime}}\right|_{\boldsymbol{\mu}=h^{(1)}\left(\mu^{(1)}\right)} \times \frac{\partial h^{(1)}\left(\mu^{(1)}\right)}{\partial \pi_{1}^{(1)}}=0
$$

by Steps 1 and 2. By way of induction, for $1 \leq i-1 \leq d_{\pi}-1$, assume that the first $i-1$ columns of $\partial g^{(i-1)}\left(0, \mu^{(i-1)}\right) / \partial \pi^{(i-1) \prime}$ are equal to zero. Then by Step 8 of the algorithm,

where the third equality results from the definition of $\mu^{(i)}$ in Step 6, the fourth equality follows from Step 7 and the final equality follows from Steps 5 and 6.

Hence, we have shown that for $1 \leq i \leq d_{\pi}$, the first $i$ columns of $\partial g^{(i)}\left(0, \mu^{(i)}\right) / \partial \pi^{(i) \prime}$ are equal to zero. In particular, $\partial g^{\left(d_{\pi}\right)}\left(0, \mu^{\left(d_{\pi}\right)}\right) / \partial \pi^{\left(d_{\pi}\right)^{\prime}}=0_{d_{g} \times d_{\pi}}$. Also note that Step 8 defines $\theta$ as equal to $\left(\beta, \mu^{\left(d_{\pi}\right)}\right)$ and

where the first equality follows from the definition of $h$ in Step 8, the second equality follows from the definition of $g^{(1)}\left(\theta^{(1)}\right)$ in Step 4 and the final two equalities follow from the definition of $g^{(i)}\left(\theta^{(i)}\right)$ in Step 8. Thus for $\beta=0$, using the definition of $h(\cdot)$ in Step 8, we have

& =\frac{\partial \boldsymbol{g}^{*}(\beta, h(\mu))}{\partial \mu^{\prime}}=\left.\frac{\partial \boldsymbol{g}^{*}(\boldsymbol{\theta})}{\partial \boldsymbol{\mu}^{\prime}}\right|_{\boldsymbol{\theta}=(\beta, h(\mu))} \times \frac{\partial h(\mu)}{\partial \mu^{\prime}}
\end{aligned}

so that $h: \mathcal{M} \rightarrow \mathcal{M}$ satisfies Procedure 3.1 if it is one-to-one. This latter property holds because each $\partial h^{(i)}\left(\mu^{(i)}\right) / \partial \mu^{(i) \prime}$ for $i=1, \ldots, d_{\pi}$ has full rank by Steps 3 and 7 and $h=$ $h^{(1)} \circ \cdots \circ h^{\left(d_{\pi}\right)}$ by Step 8.

Proof of Proposition 3.1. First, when $\beta=0$, under Assumption ID, there exists at least one column in $J^{*}(\boldsymbol{\theta})$ that is linearly dependent on the other columns wpl, which implies that there exists a nonzero vector $m^{(1)}$ such that (3.3) holds. Thus, (3.4) is a well-defined system of ODEs with an initial condition that is determined by constants of integration. By the (global) Picard-Lindelöf theorem (Picard (1893), Lindelöf (1894)), since $m^{(1)}(\cdot)$ is Lipschitz continuous on compact $\mathcal{M}^{(1)}$, there exists a solution $h^{(1)}$ on $\mathcal{M}^{(1)}$ of (3.4). Since the choice of constants of integration for this solution does not affect (3.4), it is always possible to choose them to ensure full rank of $\partial h^{(1)}\left(\mu^{(1)}\right) / \partial \mu^{(1) \prime}$. Now by way of induction, for $1 \leq i-1 \leq d_{\pi}-1$, since $\partial h^{(i)}\left(\mu^{(i)}\right) / \partial \mu^{(i) \prime}$ is full rank and $\operatorname{rank}\left(\partial g^{(i-1)}\left(\theta^{(i-1)}\right) / \partial \mu^{(i-1) \prime}\right)=r$, it follows that

Thus, there exists a nonzero vector $m^{(i)}$ such that (3.5) holds. Given (3.6), since $m^{(i)}(\cdot)$ is Lipschitz continuous on compact $\mathcal{M}^{(i)}$, there exists a solution $h^{(i)}$ on $\mathcal{M}^{(i)}$. Similarly to before, since the choice of constants of integration for this solution does not affect (3.6), it is always possible to choose them to ensure (1) and (2) of Step 7 hold. Therefore, $h=h^{(1)} \circ \ldots \circ h^{\left(d_{\pi}\right)}$ exists on $\mathcal{M}=\mathcal{M}^{\left(d_{\pi}\right)}$.

Proof of Lemma 4.1. Define $\bar{h}(\theta) \equiv(\beta, h(\mu))$. For any $\mu \in \mathcal{M}$, since $M(h(\mu))$ has full rank, $\partial h(\mu) / \partial \mu^{\prime}$ has full rank by Step 2 of Procedure 3.1. Therefore,

has full rank for any $\theta \in \Theta$. Also, since $h: \mathcal{M} \rightarrow \mathcal{M}$ is proper, $\bar{h}: \Theta \rightarrow \boldsymbol{\Theta}$ is also proper. Combining these results with Assumption H(ii), we can apply Hadamard's global inverse function theorem Hadamard (1906a,b) to $\bar{h}: \Theta \rightarrow \boldsymbol{\Theta}$, and conclude that $\bar{h}$ is a homeomorphism.

Proof of Lemma 4.2. Suppose Assumption Reg3*(v) holds. Without loss of generality, we may permute the elements of $\mu^{s}$ so that

where $D(\mu)$ is a diagonal full rank $\tilde{d}_{\pi}^{*} \times \tilde{d}_{\pi}^{*}$ matrix. By definition, the column space of $h_{\pi}^{s}(\mu)$ is equal to

which clearly satisfies the condition in Assumption Reg3*(iii) since it does not depend upon $\mu$.

The proofs of Theorem 4.1, Corollary 4.1, and Proposition 5.1 make use of the following auxiliary lemmas. The following lemma applies some of the main results of AC12.

Lemma A.1. (i) Suppose Assumptions ID, CF, Reg1 and Jac, and Assumptions B1-B3 and $\mathrm{C} 1-\mathrm{C} 6$ of AC12, applied to the $\theta$ and $Q_{n}(\theta)$ of this paper, hold. Under parameter sequences $\left\{\gamma_{n}\right\} \in \Gamma\left(\gamma_{0}, 0, b\right)$ with $\|b\|<\infty$,

(ii) Suppose Assumptions ID, CF, Reg1 and Jac, and Assumptions B1-B3, C1-C5, C7C8 and D1-D3 of AC12, applied to the $\theta$ and $Q_{n}(\theta)$ of this paper, hold. Under parameter sequences $\left\{\gamma_{n}\right\} \in \Gamma\left(\gamma_{0}, \infty, \omega_{0}\right)$,

Proof. Theorem 3.1 directly implies that Assumption A of AC12 holds when applied to the $\theta$ and $Q_{n}(\theta)$ of this paper. Then (i) and (ii) follow by direct application of Theorems $3.1(\mathrm{a})$ and $3.2(\mathrm{a})$ of AC 12.

The next lemma ensures we can write $\hat{\boldsymbol{\theta}}_{n}=\left(\hat{\beta}_{n}, h\left(\hat{\mu}_{n}\right)\right)$.
Lemma A.2. Suppose Assumptions ID, Jac and H hold. Then $\hat{\boldsymbol{\theta}}_{n}=\left(\hat{\boldsymbol{\beta}}_{n}, h\left(\hat{\mu}_{n}\right)\right)$ for some $\hat{\theta}_{n}=\left(\hat{\beta}_{n}, \hat{\mu}_{n}\right) \in \Theta$ such that $Q_{n}\left(\hat{\theta}_{n}\right)=\inf _{\theta \in \Theta} Q_{n}(\theta)+o\left(n^{-1}\right)$.

Proof. The reparameterization function $\bar{h}: \Theta \rightarrow \boldsymbol{\Theta}$ is bijective by Lemma 4.1, which implies $\boldsymbol{\Theta}=\bar{h}(\boldsymbol{\Theta})$ and $\boldsymbol{\Theta}=h^{-1}(\boldsymbol{\Theta})$ so that

Proof of Theorem 4.1. (i) Using Lemma A.2, begin by decomposing $\hat{\boldsymbol{\mu}}_{n}^{s}-\boldsymbol{\mu}_{n}^{s}=$ $h^{s}\left(\hat{\mu}_{n}\right)-h^{s}\left(\mu_{n}\right)$ as follows:

Lemma A. 1 and Assumption FD provide the marginal weak convergence of $\hat{h}_{\omega_{n}}=\left(\hat{h}_{\omega_{n}, 1}, \hat{h}_{\omega_{n}, 2}\right)$ for all sequences $\left\{\gamma_{\omega_{n}, h}\right\}$, where in the notation of McCloskey (2017), $\tilde{h}_{1}=\left(b+\tau_{0, b}^{\beta}\left(\pi_{0, b}^{*}\right), \pi_{0, b}^{*}\right)$ when $\left\|h_{1,1}\right\|<\infty, \tilde{h}_{1}=\left(b+Z_{\beta}, \pi_{0}\right)$ when $\left\|h_{1,1}\right\|=\infty$ and $h_{2}=\left(\zeta_{0}, \delta_{0}\right)$. Joint convergence of $\left(T_{\omega_{n}}\left(\theta_{\omega_{n}}\right), \hat{h}_{\omega_{n}}\right)$ follows from nearly identical arguments for joint convergence to those used in the proof of Theorem 5.1 of AC14.

Third, for Definition MLLD of McCloskey (2017), we are in what McCloskey (2017) refers to as "the usual case" for which $u=1, \tilde{W}_{h}^{(1)}=\lambda\left(\pi_{0, b}^{*} ; \gamma_{0}, b\right)$ and $\bar{H}^{(1), c}=\emptyset$ since $P\left(\left|\lambda\left(\pi_{0, b}^{*} ; \gamma_{0}, b\right)\right|<\infty\right)=1$ under the assumptions of Proposition 5.1. Since we are in the usual case, there is no need to define the auxiliary sequence of parameters $\left\{\zeta_{n}\right\}$ in that assumption (it can be any arbitrary sequence in $\mathbb{R}^{r}$ for arbitrary $r>0$ ) and $P=\mathbb{R}_{\infty}^{r}$ for any $r>0$. Fourth, for Assumption Cont-Adj of McCloskey (2017), $\bar{H}^{(1)}=H$. This assumption holds for any $\underline{\delta}^{(1)}>0$ and $\bar{\delta}^{(1)} \leq \alpha$ since $\lambda\left(\pi_{0, b}^{*} ; \gamma_{0}, b\right)$ is an absolutely continuous random variable with quantiles that are continuous in $b$ and $\pi_{0}$ and $\lambda\left(\pi_{0, b}^{*} ; \gamma_{0}, b\right) \stackrel{d}{\sim} \chi_{d_{r}}^{2}$ for any $b$ such that $\|b\|=\infty$. Fifth, Assumption Sel holds trivially since we are in the "usual case."

Sixth, Assumption CS of McCloskey (2017) can be modified and applied to $\hat{I}_{n}^{a}(\cdot)$ and its limit counterpart $I_{0}^{a}(\cdot)$ so that: (i)

The proof of Theorem Bonf-Adj in McCloskey (2017) still goes through with this modification of Assumption CS. Condition (i) is satisfied by the consistency of ( $\hat{\zeta}_{n}, \hat{\delta}_{n}$ ) and the uniform consistency of $\hat{\Sigma}_{n}(\cdot)$ under any $\left\{\gamma_{n}\right\} \in \Gamma\left(\gamma_{0}\right)$. Seventh, note that rather than using a quantile adjustment function $\left(a^{(j)}(\cdot)\right.$ in the notation of McCloskey (2017)), we are fixing the quantile at level $1-\alpha$ and adding a size-correction function $\boldsymbol{s}(\cdot)$ to it. The proof of Theorem Bonf-Adj of McCloskey (2017) can be easily adjusted to this modification. Rather than requiring the quantile adjustment function to be continuous, the proof requires $s(\cdot)$ to be continuous. That is, Assumption a(i) of McCloskey (2017) may be replaced by the analogous assumption: $\boldsymbol{s}(\cdot)$ is continuous. In practice, $\boldsymbol{s}(\cdot)$ is only evaluated at the point $\left(\hat{\zeta}_{n}, \hat{\delta}_{n}, \hat{\bar{\Sigma}}_{n}\right)$, which is consistent with this assumption. We now proceed to verify the imposed assumptions for the threshold crossing model example. Hereafter, Andrews and Cheng (2013a) and Han and Vytlacil (2017) are abbreviated as AC13 and HV17. The supplemental material for AC12, AC13, and AC14, Andrews and Cheng (2012, 2013b, 2014), are abbreviated as AC12supp, AC13supp, and AC14supp. The working paper version of AC13 is abbreviated as ACMLwp. And "with respect to" is abbreviated as "w.r.t."

## B. 1 Assumptions for threshold crossing models

The assumptions in the main text of the current paper and the assumptions in AC12 on objects involving the transformed parameter $\theta$ are verified under assumptions introduced in this section. The assumptions in AC 12 are verified by verifying those in AC 13 .

(iii) $(\varepsilon, \nu)^{\prime} \sim F_{\varepsilon \nu}(\varepsilon, \nu)=C\left(F_{\varepsilon}(\varepsilon), F_{\nu}(v) ; \pi\right)$ where $C:(0,1)^{2} \rightarrow(0,1)$ is a copula known up to a scalar parameter $\pi \in \Pi$ such that $C\left(u_{1}, u_{2}, ; \pi\right)$ is three-times differentiable in $\left(u_{1}, u_{2}, \pi\right) \in(0,1)^{2} \times \Pi$;
(iv) The copula $C\left(u_{1}, u_{2}, ; \pi\right)$ satisfies

Given the form of $h$ in (3.8) of HM 18 with $c_{4}(\zeta)$ set equal to zero, we write $\pi=\pi_{3}$ in this assumption and below. The conditions in TC2 are sufficient for (global) identification of $\boldsymbol{\theta}$ when $\beta \neq 0$. The argument is similar to that in HV17, except that the condition for the parameter space TC2(vi) is stronger than that in HV17.

Assumption TC4(ii) guarantees that the true parameter space includes a region where weak identification occurs and TC4(iii) ensures that $\Gamma$ is consistent with the existence of $K(\theta ; \gamma)$, defined later.

Assumption TC5. (i) $C\left(u_{1}, u_{2}, ; \pi\right)$ is bounded away from zero over $(0,1)^{2} \times \Pi$;
(ii) $0<\phi_{1} \equiv \operatorname{Pr}_{\gamma}[Z=1]<1 \forall \gamma \in \Gamma$.

## B. 2 Verification of assumptions in the main text

Assumptions CF, ID, Jac, and Reg3 are verified in the main text. For Assumption H, H(i) holds since its sufficient conditions that $\Theta$ is bounded and $h$ is continuous hold by $\mathrm{S} 2(\mathrm{v})$, verified below, and by Proposition 3.1 of HM18, respectively. H(ii) is also trivially satisfied by TC3(i). For Reg2, $\operatorname{rank}\left(h_{\pi}^{s}(\mu)\right)=1$ if $h^{s}(\pi)$ contains $h_{2}(\pi), h_{3}(\pi)$ or $h_{4}(\pi)$ and $\operatorname{rank}\left(h_{\pi}^{s}(\mu)\right)=0$ otherwise, as can be seen from the form of $h$ in (3.8) of HM18 upon setting $c_{1}(\zeta)=\zeta_{1}, c_{2}(\zeta)=\zeta_{2}$, $c_{3}(\zeta)=\zeta_{3}$, and $c_{4}(\zeta)=0$.

## B. 3 Verification of assumptions in Andrews and Cheng (2013)

In this section, given our transformed parameter $\theta$ and associated transformed objects, we verify the regularity conditions for the asymptotic theory of the ML estimator $\hat{\theta}_{n}$ in AC13. Specifically, we show that Assumptions TC1-TC5 are sufficient for Assumptions S1-S4, B1, B2, C6, C7, V1, and V2 of AC13. Then, under Assumptions B1 and B2, Assumptions S1-S3 of AC13 imply Assumptions A, B3, C1-C4, C8, and D1-D3 of AC12; see Lemma 9.1 in ACMLwp. Maintaining the same labels of AC13, below we rewrite the assumptions of AC13 before verifying them. Note that in our stylized threshold crossing model, $\beta$ is scalar. Therefore, we do not consider Assumptions S3* and V1* of AC13 which apply to the vector $\beta$ case.

We can show that $a_{y d, z}\left(\pi, \theta_{0}, \phi_{1,0}\right)$ is continuous uniformly in $\pi \in \Pi$ by applying the uniform convergence result in Lemma 9.2 of ACMLwp to $a_{y d, z}\left(\pi, \theta_{n}, \phi_{1, n}\right)-a_{y d, z}\left(\pi, \theta_{0}, \phi_{1,0}\right)$, using (i) the pointwise convergence (i.e., pointwise continuity) above, (ii) $a_{y d, z}\left(\pi, \theta_{0}, \phi_{1,0}\right)$ 's differentiability in $\pi$ with derivatives bounded over $\pi \in \Pi$ by Lemma B. 1 and (iii) the compactness of $\Pi$ (B1 (iii) below).

Next, we impose conditions on the parameter spaces $\Theta$ and $\Gamma$. Recall $\Theta_{\delta}^{*} \equiv\left\{\theta \in \Theta^{*}\right.$ : $|\beta|<\delta\}$, where $\Theta^{*}$ is the true parameter space for $\theta$. The "optimization parameter space" $\Theta$ satisfies the following.

Assumption B1 (AC13). (i) $\operatorname{int}(\Theta) \supset \Theta^{*}$.
(ii) For some $\delta>0, \Theta \supset\left\{\beta \in \mathbb{R}^{d_{\beta}}:|\beta|<\delta\right\} \times \mathcal{Z}^{0} \times \Pi \supset \Theta_{\delta}^{*}$ for some nonempty open set $\mathcal{Z}^{0} \subset \mathbb{R}^{d_{\zeta}}$ and $\Pi$.
(iii) $\Pi$ is compact.

The following general results are useful in verifying B1 and B2 below: for a continuous function $f$, (i) if a set $A$ is compact, then $f(A)$ is compact and (ii) $f^{-1}(\operatorname{int}(A)) \subset$ $\operatorname{int}\left(f^{-1}(A)\right)$ for any set $A$ in the range of $f$, where the latter is necessary and sufficient for continuity. Also note that by definition, for a proper function $f$, if $B$ is compact, then $f^{-1}(B)$ is compact. Lastly, for a function $f$, if $A \subset B$ then $f(A) \subset f(B)$.

Verification of B1. TC3(ii) implies B1(i) since

where $\mathcal{M}^{*}=\left\{\mu \in \mathbb{R}^{d_{\mu}}: \theta=(\beta, \mu)\right.$ for some $\left.\theta \in \Theta^{*}\right\}$, the second equality holds since $\bar{h}(\theta)=(\beta, h(\mu))$ and the last equality holds by TC3(iv). Lastly, B 1 (iii) holds by TC3(i).

Assumption B2 (AC13). (i) $\Gamma$ is compact and $\Gamma=\left\{\gamma=(\theta, \phi): \theta \in \Theta^{*}, \phi \in \Phi^{*}(\theta)\right\}$.
(ii) $\forall \delta>0, \exists \gamma=(\beta, \zeta, \pi, \phi) \in \Gamma$ with $0<\|\beta\|<\delta$.
(iii) $\forall \gamma=(\beta, \zeta, \pi, \phi) \in \Gamma$ with $0<\|\beta\|<\delta$ for some $\delta>0, \gamma_{a}=(a \beta, \zeta, \pi, \phi) \in \Gamma \forall a \in$ [0, 1].

Verification of B2. Consider B2(i). Under TC4(i), define $\Phi^{*}(\theta)$ as $\Phi^{*}(\theta) \equiv \boldsymbol{\Phi}^{*}(\bar{h}(\theta))$. Since $\boldsymbol{\Gamma}$ is compact, $\boldsymbol{\Theta}^{*}$ and $\boldsymbol{\Phi}^{*}(\boldsymbol{\theta})$ are compact for $\boldsymbol{\theta} \in \boldsymbol{\Theta}^{*}$. Thus, $\Theta^{*}=\bar{h}^{-1}\left(\boldsymbol{\Theta}^{*}\right)$ is compact by the properness of $\bar{h}$. Also given (B.4), we have

Therefore, $\tilde{M}_{01,1}^{*}+\tilde{M}_{10,1}^{*}+\tilde{M}_{11,1}^{*}$ is positive definite and by (B.27), we can easily show that $\lambda_{\min }\left(\Omega_{G}\left(\pi_{1}, \pi_{2} ; \psi_{0}\right)\right)>0$.

Define a nonstochastic function $\left\{\eta\left(\pi ; \gamma_{0}\right): \pi \in \Pi\right\}$ by

$$
\eta\left(\pi ; \gamma_{0}\right) \equiv-\frac{1}{2} K\left(\pi ; \gamma_{0}\right)^{\prime} H^{-1}\left(\pi ; \gamma_{0}\right) K\left(\pi ; \gamma_{0}\right)
$$

Assumption C7. The nonstochastic function $\eta\left(\pi ; \gamma_{0}\right)$ is uniquely minimized over $\pi \in \Pi$ at $\pi_{0} \forall \gamma_{0} \in \Gamma$ with $\beta_{0}=0$.

For $\beta_{0}=0$, by (B.15)-(B.16) we can write

\begin{aligned}
& K\left(\pi ; \gamma_{0}\right)=-\sum_{y, d, z=0,1} \frac{\phi_{z, 0}}{p_{y d}^{0}} \frac{\partial p_{y d, z}\left(\theta_{0}\right)}{\partial \beta_{0}} D_{\psi} p_{y d, z}\left(\psi_{0}, \pi\right) \\
& H\left(\pi ; \gamma_{0}\right)=\sum_{y, d, z=0,1} \frac{\phi_{z, 0}}{p_{y d}^{0}} D_{\psi} p_{y d, z}\left(\psi_{0}, \pi\right) D_{\psi} p_{y d, z}\left(\psi_{0}, \pi\right)^{\prime}
\end{aligned}
$$

Note that we can partition $H(\pi)$ and $K(\pi)$, suppressing $\gamma_{0}$, as

$$
\left.\left.H(\pi)=\left[\begin{array}{cc}
H_{11}(\pi) & H_{12}(\pi) \\
H_{21}(\pi) & H_{22}
\end{array}\right]\right\} d_{\beta} \quad \text { and } \quad K(\pi)=\binom{K_{1}(\pi)}{K_{2}}\right\} d_{\zeta}
$$

and note that $K\left(\pi_{0}\right)=\left[-H_{11}\left(\pi_{0}\right):-H_{21}\left(\pi_{0}\right)^{\prime}\right]^{\prime}$ by the expressions for $K\left(\pi ; \gamma_{0}\right)$ and $H\left(\pi ; \gamma_{0}\right)$.

Verification of C7. We first show that, for any $\pi \in \Pi$,

$$

For matrices $A$ and $B$, let $A \leq B$ denote $B-A$ being p.s.d. Then we can show that

K(\pi)^{\prime} H^{-1}(\pi) K(\pi) \leq H_{11}\left(\pi_{0}\right)=K\left(\pi_{0}\right)^{\prime} H^{-1}\left(\pi_{0}\right) K\left(\pi_{0}\right) \tag{B.36}
\end{equation*}
$$

where the inequality is an application of the matrix Cauchy-Schwarz inequality (Proposition B. 1 below) and the equality holds because $K\left(\pi_{0}\right)=\left[-H_{11}\left(\pi_{0}\right):-H_{21}\left(\pi_{0}\right)^{\prime}\right]^{\prime}$; see below for the proof. Lastly, the weak inequality in (B.36) holds as an equality if and only if $\rho_{\beta}\left(W_{i}, \psi_{0}, \pi_{0}\right) a+\rho_{\psi}\left(W_{i}, \psi_{0}, \pi\right)^{\prime} b=0$ with probability 1 for some $a \in \mathbb{R}$ and $b \in \mathbb{R}^{d_{\psi}}$ with $\left(a, b^{\prime}\right) \neq 0$. Let $D_{\beta} p_{y d, z}^{0} \equiv D_{\beta} p_{y d, z}\left(\psi_{0}, \pi_{0}\right)$ and $D_{\psi} p_{y d, z}(\pi) \equiv D_{\psi} p_{y d, z}\left(\psi_{0}, \pi\right)$ for simplicity. Then, when $\beta_{0}=0$,

$$
\rho_{\beta}\left(W_{i}, \psi_{0}, \pi_{0}\right) a+\rho_{\psi}\left(W_{i}, \psi_{0}, \pi\right)^{\prime} b=\sum_{y, d, z=0,1} \frac{\mathbf{1}_{y d z}\left(W_{i}\right)}{p_{y d}^{0}}\left[D_{\beta} p_{y d, z}^{0} a+D_{\psi} p_{y d, z}(\pi)^{\prime} b\right] .
$$

But, it is easy to see that a $\left(1+d_{\psi}\right) \times 8$ matrix (suppressing $\pi$ in $D_{\psi} p_{y d, z}(\pi)$ and letting $h_{3,0} \equiv h_{3}\left(\pi_{0}\right)$ and $\left.h_{2,0} \equiv h_{2}\left(\pi_{0}\right)\right)$

$$
\begin{aligned}
& {\left[\begin{array}{cccccccccc}
D_{\beta} p_{11,1}^{0} & D_{\beta} p_{10,1}^{0} & D_{\beta} p_{01,1}^{0} & D_{\beta} p_{00,1}^{0} & D_{\beta} p_{11,0}^{0} & D_{\beta} p_{10,0}^{0} & D_{\beta} p_{01,0}^{0} & D_{\beta} p_{00,0}^{0} \\
D_{\psi} p_{11,1} & D_{\psi} p_{10,1} & D_{\psi} p_{01,1} & D_{\psi} p_{00,1} & D_{\psi} p_{11,0} & D_{\psi} p_{10,0} & D_{\psi} p_{01,0} & D_{\psi} p_{00,0}
\end{array}\right]} \\
& \quad=\left[\begin{array}{cccccccc}
C_{2}\left(h_{3,0} ; \zeta_{10}, \pi_{0}\right) & -C_{2}\left(h_{2,0}, \zeta_{10} ; \pi_{0}\right) & 1-C_{2}\left(h_{3,0}, \zeta_{10} ; \pi_{0}\right) & -1+C_{2}\left(h_{2,0}, \zeta_{10} ; \pi_{0}\right) & 0 & 0 & 0 & 0 \\
C_{2}\left(h_{3} ; \zeta_{10}, \pi_{0}\right) & -C_{2}\left(h_{2}, \zeta_{10} ; \pi_{0}\right) & 1-C_{2}\left(h_{3}, \zeta_{10} ; \pi_{0}\right) & -1+C_{2}\left(h_{2}, \zeta_{10} ; \pi_{0}\right) & 0 & 0 & 0 & 0 \\
0 & 0 & 1 & -1 & 0 & 0 & 1 & -1 \\
0 & 1 & 0 & -1 & 0 & 1 & 0 & -1 \\
1 & 0 & -1 & 0 & 1 & 0 & -1 & 0
\end{array}\right]
\end{aligned}
$$

has full row rank (i.e., rank of $1+d_{\psi}$ ) except when $\pi=\pi_{0}$, since

& C_{2}\left(h_{3}(\pi), \zeta_{10} ; \pi\right) \neq C_{2}\left(h_{3}\left(\pi_{0}\right), \zeta_{10} ; \pi_{0}\right), \\
& C_{2}\left(h_{2}(\pi), \zeta_{10} ; \pi\right) \neq C_{2}\left(h_{2}\left(\pi_{0}\right), \zeta_{10} ; \pi_{0}\right)
\end{aligned}
$$

for $\pi \neq \pi_{0}$. This can be shown by modifying the proof of Lemmas 3.1 and 4.1 of HV17 under Assumption TC2, which yields

\partial C_{2}\left(h_{3}(\pi), \zeta_{1} ; \pi\right) / \partial \pi=C_{\pi 2}\left(h_{3}(\pi), \zeta_{1} ; \pi\right)+C_{12}\left(h_{3}(\pi), \zeta_{1} ; \pi\right) h_{3, \pi}(\pi)<0
$$

and

C_{\pi 2}\left(h_{2}(\pi), \zeta_{1} ; \pi\right)+C_{12}\left(h_{2}(\pi), \zeta_{1} ; \pi\right) h_{2, \pi}(\pi)<0
$$

In fact, $h_{2}$ or $h_{3}$ can be seen as $u_{1}^{*}$ in Lemma 4.1 of HV17. Therefore, there is no ( $a, b^{\prime}$ ) with $\left(a, b^{\prime}\right) \neq 0$ such that $D_{\beta} p_{y d, z}^{0} a+D_{\psi} p_{y d, z}^{\prime}(\pi) b=0$ for all $(y, d, z) \in\{0,1\}^{3}$, which implies that there is no $\left(a, b^{\prime}\right)$ with $\left(a, b^{\prime}\right) \neq 0$ such that $\rho_{\beta}\left(W_{i}, \psi_{0}, \pi_{0}\right) a+\rho_{\psi}\left(W_{i}, \psi_{0}, \pi\right)^{\prime} b=0$ with probability 1 . In other words, the equality holds uniquely at $\pi=\pi_{0}$ so that for any $\pi \neq \pi_{0}, \operatorname{Pr}\left[c^{\prime}\left(\rho_{\beta}\left(W_{i}, \psi_{0}, \pi_{0}\right), \rho_{\psi}\left(W_{i}, \psi_{0}, \pi\right)^{\prime}\right)^{\prime}=0\right]<1$ for all $c \in \mathbb{R}^{d_{\beta}+d_{\psi}}$ with $c \neq 0$, and thus the inequality in (B.36) is strict.

Proposition B.1. Let $x \in \mathbb{R}^{p}$ and $y \in \mathbb{R}^{q}$ be random vectors such that $E\|x\|^{2}<\infty$, $E\|y\|^{2}<\infty$, and Eyy' is nonsingular. Then

Proof of $H_{11}\left(\pi_{0}\right)=K\left(\pi_{0}\right)^{\prime} H^{-1}\left(\pi_{0}\right) K\left(\pi_{0}\right)$. Define a $4 \times 4$ block-diagonalizing matrix

1 & -H_{12}(r) H_{22}^{-1} \\
0_{3} & I_{3}
\end{array}\right] .

Then

K\left(r_{0}\right)^{\prime} H^{-1}\left(r_{0}\right) K\left(r_{0}\right)= & K\left(r_{0}\right)^{\prime} A(r)\left[A(r) H\left(r_{0}\right) A(r)\right]^{-1} A(r) K\left(r_{0}\right) \\
= & (-1)^{2}\left[H_{11}\left(r_{0}\right): H_{21}\left(r_{0}\right)^{\prime}\right] A(r)\left[A(r) H\left(r_{0}\right) A(r)\right]^{-1} A(r)\left[\begin{array}{c}
H_{11}\left(r_{0}\right) \\
H_{21}\left(r_{0}\right)
\end{array}\right] \\
= & {\left[H_{11}\left(r_{0}\right)-H_{12}\left(r_{0}\right) H_{22}^{-1} H_{21}\left(r_{0}\right): H_{21}\left(r_{0}\right)^{\prime}\right]\left[\begin{array}{cc}
H_{11}^{*}\left(r_{0}\right)^{-1} & 0 \\
0 & H_{22}^{-1}
\end{array}\right] } \\
& \times\left[\begin{array}{c}
H_{11}\left(r_{0}\right)-H_{12}\left(r_{0}\right) H_{22}^{-1} H_{21}\left(r_{0}\right) \\
H_{21}\left(r_{0}\right)
\end{array}\right] \\
= & {\left[1: H_{21}\left(r_{0}\right)^{\prime} H_{22}^{-1}\right]\left[\begin{array}{c}
H_{11}\left(r_{0}\right)-H_{12}\left(r_{0}\right) H_{22}^{-1} H_{21}\left(r_{0}\right) \\
H_{21}\left(r_{0}\right)
\end{array}\right] } \\
= & H_{11}\left(r_{0}\right),
\end{aligned}
$$

where the second equality is due to the fact that $K\left(r_{0}\right)=\left[-H_{11}\left(r_{0}\right):-H_{21}\left(r_{0}\right)^{\prime}\right]^{\prime}$ and $H_{11}^{*}\left(r_{0}\right)$ is implicitly defined. We also use the symmetry of $H(r)$ in this derivation.

Define the following quantities that arise in the asymptotic distribution of $\hat{\theta}_{n}$ and the test statistics we consider. Letting $S_{\psi} \equiv\left[I_{d_{\psi}}: 0_{d_{\psi} \times 1}\right]$ denote the $d_{\psi} \times d_{\theta}$ selector matrix that selects $\psi$ out of $\theta$ :

V\left(\theta ; \gamma_{0}\right) & =V^{\dagger}\left(\theta, \theta ; \gamma_{0}\right)
\end{aligned}
$$

and

$$
\begin{aligned}
J\left(\gamma_{0}\right) & \equiv J\left(\theta_{0} ; \gamma_{0}\right) \\
V\left(\gamma_{0}\right) & \equiv V\left(\theta_{0} ; \gamma_{0}\right)
\end{aligned}
$$

Note that

$$
J\left(\gamma_{0}\right)=V\left(\gamma_{0}\right)
$$

by (B.33). Define

$$
\Sigma\left(\theta ; \gamma_{0}\right) \equiv J^{-1}\left(\theta ; \gamma_{0}\right) V\left(\theta ; \gamma_{0}\right) J^{-1}\left(\theta ; \gamma_{0}\right)
$$

and

$$
\Sigma\left(\pi ; \gamma_{0}\right) \equiv \Sigma\left(\psi_{0}, \pi ; \gamma_{0}\right)
$$

Assumption V1. (i) $\widehat{J}_{n}=\widehat{J}_{n}\left(\widehat{\theta}_{n}\right)$ and $\widehat{V}_{n}=\widehat{V}_{n}\left(\widehat{\theta}_{n}\right)$ for some (stochastic) $d_{\theta} \times d_{\theta}$ matrixvalued functions $\widehat{J}_{n}(\theta)$ and $\widehat{V}_{n}(\theta)$ on $\Theta$ that satisfy $\sup _{\theta \in \Theta}\left\|\widehat{J}_{n}(\theta)-J\left(\theta ; \gamma_{0}\right)\right\| \rightarrow_{p} 0$ and $\sup _{\theta \in \Theta}\left\|\widehat{V}_{n}(\theta)-V\left(\theta ; \gamma_{0}\right)\right\| \rightarrow{ }_{p} 0$ under $\left\{\gamma_{n}\right\} \in \Gamma\left(\gamma_{0}, 0, b\right)$ with $\|b\|<\infty$.
(ii) $J\left(\theta ; \gamma_{0}\right)$ and $V\left(\theta ; \gamma_{0}\right)$ are continuous in $\theta$ on $\Theta \forall \gamma_{0} \in \Gamma$ with $\beta_{0}=0$.
(iii) $\lambda_{\min }\left(\Sigma\left(\pi ; \gamma_{0}\right)\right)>0$ and $\lambda_{\max }\left(\Sigma\left(\pi ; \gamma_{0}\right)\right)<\infty \forall \pi \in \Pi, \forall \gamma_{0} \in \Gamma$ with $\beta_{0}=0$.

Verification of V1(i). We define the following:

& =\frac{1}{n} \sum_{i=1}^{n} \sum_{y, d, z=0,1} \mathbf{1}_{y d z}\left(W_{i}\right) \frac{D_{\theta} p_{y d, z}^{\dagger}(\theta) D_{\theta} p_{y d, z}^{\dagger}(\theta)^{\prime}}{p_{y d, z}(\theta)^{2}}
\end{aligned}
$$

where $D_{\theta} p_{y d, z}^{\dagger}\left(\theta_{0}\right)$ are defined above. Also,

$$
\begin{aligned}
\widehat{V}_{n}(\theta) & \equiv \frac{1}{n} \sum_{i=1}^{n} \rho_{\theta}^{\dagger}\left(W_{i}, \theta\right) \rho_{\theta}^{\dagger}\left(W_{i}, \theta\right)^{\prime} \\
& =\frac{1}{n} \sum_{i=1}^{n} \sum_{y, d, z=0,1} \mathbf{1}_{y d z}\left(W_{i}\right) \frac{D_{\theta} p_{y d, z}^{\dagger}(\theta) D_{\theta} p_{y d, z}^{\dagger}(\theta)^{\prime}}{p_{y d, z}(\theta)^{2}}=\widehat{J}_{n}(\theta)
\end{aligned}
$$

The rest of the proof follows from the uniform law of large numbers in Lemma 9.3 of ACMLwp with Assumptions S1 and S3 and $\Theta$ being compact.

Verification of V1(ii). The continuity follows from the fact that the first and second derivatives of $p_{y d, z}(\theta)$ are continuous by Lemma B.1(vi).

Verification of V1(iii). Note that

\Sigma\left(\pi ; \gamma_{0}\right)=J^{-1}\left(\psi_{0}, \pi ; \gamma_{0}\right) V\left(\psi_{0}, \pi ; \gamma_{0}\right) J^{-1}\left(\psi_{0}, \pi ; \gamma_{0}\right)=V^{-1}\left(\psi_{0}, \pi ; \gamma_{0}\right)
$$

since $V\left(\psi_{0}, \pi ; \gamma_{0}\right)=J\left(\psi_{0}, \pi ; \gamma_{0}\right)$. This is because

V\left(\psi_{0}, \pi ; \gamma_{0}\right) & =\operatorname{Cov}_{\gamma_{0}}\left(\rho_{\theta}^{\dagger}\left(W_{i}, \psi_{0}, \pi\right), \rho_{\theta}^{\dagger}\left(W_{i}, \psi_{0}, \pi\right)\right)=E_{\gamma_{0}} \rho_{\theta}^{\dagger}\left(W_{i} ; \psi_{0}, \pi\right) \rho_{\theta}^{\dagger}\left(W_{i} ; \psi_{0}, \pi\right)^{\prime} \\
& =E_{\gamma_{0}} \rho_{\theta \theta}^{\dagger}\left(W_{i} ; \theta\right)
\end{aligned}
$$

where the last equality holds since $\rho_{\theta \theta}^{\dagger}(w, \theta)=\rho_{\theta}^{\dagger}(w, \theta) \rho_{\theta}^{\dagger}(w, \theta)^{\prime}$, and the second-to-last equality holds since

\begin{aligned}
E_{\gamma_{0}} \rho_{\theta}^{\dagger}\left(W_{i}, \psi_{0}, \pi\right) & =-\sum_{y, d, z=0,1} \phi_{z, 0} D_{\theta} p_{y d, z}^{\dagger}\left(\psi_{0}, \pi\right) \\
& =-\sum_{y, d=0,1} \phi_{0,0} D_{\theta} p_{y d, 0}^{\dagger}\left(\psi_{0}, \pi\right)-\sum_{y, d=0,1} \phi_{1,0} D_{\theta} p_{y d, 1}^{\dagger}\left(\psi_{0}, \pi\right) \\
& =0
\end{aligned}
$$

Now, for the first part of V1(iii), note that since each element of the vectors in (B.28)(B.31) are bounded by TC2(iii) and B2(i), the elements of the matrix

V\left(\psi_{0}, \pi ; \gamma_{0}\right) & =E_{\gamma_{0}} \rho_{\theta}^{\dagger}\left(W_{i} ; \psi_{0}, \pi\right) \rho_{\theta}^{\dagger}\left(W_{i} ; \psi_{0}, \pi\right)^{\prime} \\
& =\sum_{y, d, z=0,1} \frac{\phi_{z, 0}}{p_{y d, 0}} D_{\theta} p_{y d, z}^{\dagger}\left(\psi_{0}, \pi\right) D_{\theta} p_{y d, z}^{\dagger}\left(\psi_{0}, \pi\right)^{\prime}
\end{aligned}
$$

are bounded. For a $d \times d$ matrix $A, \sum_{i=1}^{d}\left|\lambda_{i}\right| \leq \sum_{i, j=1}^{d}\left|A_{i j}\right|$ where the $\lambda_{i}$ 's are $A$ 's eigenvalues and the $A_{i j}$ 's are $A$ 's elements. Therefore, $\lambda_{\max }\left(V\left(\psi_{0}, \pi ; \gamma_{0}\right)\right)<\infty$. This implies that $\lambda_{\min }\left(V^{-1}\left(\psi_{0}, \pi ; \gamma_{0}\right)\right)>0$. By Lemma B.1, the proof of the second part is similar to the proofs of S3(iv)(b) and S3(v) and we can show that $\lambda_{\min }\left(V\left(\psi_{0}, \pi ; \gamma_{0}\right)\right)>0$, which implies that $\lambda_{\max }\left(V^{-1}\left(\psi_{0}, \pi ; \gamma_{0}\right)\right)<\infty$.
